

Field Operations Programs Supplemental Nutrition Assistance Program (SNAP)











FY 2018 TOTAL COLLECTIONS

(ACCUMULATED MONTHLY)







NEW CLIENTS SERVED FEDERAL FISCAL YEAR 2018*





