
Field Operations Programs Supplemental Nutrition Assistance Program (SNAP)









Field Operations Programs Child Support Enforcement Program




FY 2016 TOTAL COLLECTIONS

(ACCUMULATED MONTHLY)










Mississippi Department of Human Services Monthly IV-E/IV-B Penetration Rate

NEW CLIENTS SERVED FEDERAL FISCAL YEAR 2016*









