Vendors are reminded that any protests of this decision must be submitted to Bryan C. Wardlaw, Chief Procurement Officer, within seven (7) calendar days after the issuance of this notice or no

later than September 23, 2020, 1:00 PM, CT. The protest must be in writing, identify the name and address of the protestor, provide appropriate identification of the procurement and resulting subgrant number (if known), and detail the nature of the protest, including available supporting exhibits, evidence, or documents to substantiate any claims.

Awarded Respondents are hereby instructed not to begin work, purchase materials, or enter into subcontracts relating to the project or services until execution of the subgrant agreement.
