Amendments to the RFP are as follows:

1. Section 2.3.1.31 through Section 2.3.1.34 is amended to reflect the following:

- 2.3.1.31** Provide prompt assistance to MDHS in responding to any Public Records requests, PEER Committee requests, legislative requests, or similar requests for information.
- 2.3.1.32** Cooperating with the Attorney General's Office and/or any other state or federal prosecutor on felony non-payment of child support cases.
- 2.3.1.33** Employ trained staff to handle child support inquires and casework. Cross training staff is encouraged.
- 2.3.1.34** Handle incoming USPS mail as designated by MDHS, which includes, but is not limited to, receiving mail though the use of a post office box, scanning mail into the proper system, updating METSS appropriately and updating information any other system.

2. Section 2.3.6.11.2 is amended to reflect the following:

- 2.3.6.11.2** **MANDATORY.** The Respondent shall be responsible for paying all filing fees and submitting to MDHS a separate itemized invoice on a monthly basis for reimbursement. The Respondent shall be responsible for all service of process requirements and paying for these services. MDHS will not reimburse Respondent for any associated service of process costs.

3. Section 2.3.15.10 Emergency Plan is amended to reflect the following:

- 2.3.15.10** **Emergency Plan:** Describe the entity's proposed emergency response continuity of operations plan. Attach a copy of the entity's plan or summarize how the entity's plan addresses the following aspects of pandemic preparedness and natural disaster recovery, including:
 - a. Employee training;
 - b. Essential business functions and responsible key employees;
 - c. Contingency plans for covering essential business functions in the event key employees are incapacitated or the primary workplace is unavailable, which shall include, but is not limited to addressing continued compliance with federal and/or state audit, security and confidentiality obligations in the event of extended displacement;
 - d. Communication with staff and suppliers when normal systems are unavailable;
 - e. Plans to ensure continuity of services to customers; and,
 - f. Testing plan.

Additionally, any such plan would need to include assurance that during normal business hours there would be adequate staffing on-site to address all clients’ needs on a walk-in basis.</u></p>

And if so, is the intent of 2.3.6.19.13 to ensure any recouped costs are received by MDHS and not the vendor? If so, will MDHS clarify this section? Please note, this is a substantial sum and we believe a clear understanding is needed so all Respondents have the same understanding. Also, if 2.3.6.19.13 prohibits reimbursement of some or all of the court cost that might otherwise be covered under 2.3.6.11.2, please give historical monthly volumes for those cost over the past year.</p> <p><u>ANSWER: See Number 2 on page 1 of this Amendment. The only change from current practice is that the vendor pays the bill and is then reimbursed. The rationale of this change is to avoid delays in cases being heard as a result of delays with the State’s billing process.</u></p>
18	16	2.3.6.11.4	<p>Current practice allows clients who signed an ASAP but who are within the recension period (one year) to request and receive a genetic test. Is this section intended to stop that practice?</p> <p><u>ANSWER: No, clients who signed an ASAP but are within the recension period (one year) can continue to request and receive a genetic test. This section is intended to clarify that DNA should not be allowed beyond the one-year recension period without a court order.</u></p>
19	16	2.3.6.11.5	<p>This section states, “Respondents shall provide notice to the NCP of all potential legal consequences of declining genetic testing. Respondent shall document such notice to the NCP and retain documentation as part of the case file.” NCPs are routinely noticed of potential consequences in office interviews, through the Genetic Test letter (“104”), or through the NCP appointment letter (“112”)? Is this requirement a change to existing policy or practice?</p> <p><u>ANSWER: When verbal notice is given in the course of an office interview or agreed judgment such notice should be notated in METSS. This requirement may include a change to existing policy by adding language to judgments or use of a waiver.</u></p>
20	17	2.3.6.11.13	<p>2.3.6.11.13 provides that the vendor must enter all court orders into METSS and obligate the debt within two business days of the order being “entered by the court...” Under current court practice in almost all counties, the vendor only receives orders after the clerk of the court has entered the order into the case, created copies and either mails, delivers, or notifies the vendor that the order has been entered. Because of processes in the office of the clerk, we may only receive the order several days later, depending on the actions of the chancery clerk. Currently, the standard is measured from when the order is “received from the court.” Does MDHS actually mean, or will it change the standard to be, that the two days will be from when we receive the order? Note: other sections of the RFP require us to stamp the date of receipt on incoming documents.</p> <p><u>ANSWER: Given past issues with timely order entry, this provision is to clarify the two day requirement is when the vendor receives (or should have reasonably received) the order, not when the order is scanned in the agency system or swept</u></p>

The Emergency Plan is due as part of the response, while the Disaster Plan is only due in outline form that is to be developed post award. If these are synonyms, please clarify what is desired in the proposal. If they are different plans, please explain the differences. <u>ANSWER: An Emergency Plan should be provided with the details specified in the RFP. It will be incorporated into and consistent with any Disaster Plan developed post award. MDHS recognizes that potential Respondents would not have the capabilities to present a complete Disaster Plan before knowing the final geographical bounds of the service area of the contract(s).</u>
33	46	2.6	Section 2.6 and the related Footnote 1 provide that Contractor's invoice shall reflect the "costs of services actually provided" and should reflect the "pro rata amounts for filled Respondent positions that actually performed and/or provided services during the prior month." (a) How are the pro rata amounts calculated? (b) If an employee provides services for only a portion of the month, should the Contractor invoice only reflect the actual pay for that employee for the month? <u>ANSWER: (a) Total monthly Wages/days worked; and (b) Yes</u>

Excessive delays between receipt of the application and filing with the court will be reviewed by the MDHS monitoring unit.</u></p>
41		General	<p>MDHS has historically made COGNOS available to the vendor. We understand COGNOS is nearing end of life. Once COGNOS is no longer available, will MDHS agree to give the vendor files and/or data in electronic form from METSS that can be used for mining data, creating lists and such things if the request for the files is reasonable and necessary for operations? Will MDHS be willing to discuss this or alternatives in negotiations?</p> <p><u>ANSWER: MDHS may be willing to discuss this during negotiations.</u></p>
42		General	<p>In the event MDHS awards the genetic testing plan of the Respondent, will MDHS add the Respondent’s Genetic Testing vendor to the approved list pursuant to State Statute 93-9-23?</p> <p><u>ANSWER: The statute cited in the question does not reference the approved list.</u></p>
43		General	<p>If during the Contract term, there are statute, policy or other changes are made that substantially increase the number of new case referrals to the vendor significantly over what is now being experienced, will MDHS treat that as a contract change? If not, are there any anticipated changes that may alter the current sources of applications and/or referrals?</p> <p><u>ANSWER: As MDHS does not currently anticipate any changes that would significantly alter the current sources of applications and/or referrals, MDHS would not consider an increase in the number of new case referrals to constitute a contract change.</u></p>
