MDHS issued Request for Proposal (RFP) No. 20200102 OANP (RFx 3180001111/31200022023) for the Older Adult Nutrition Program on July 1, 2020. As a result, one (1) vendor submitted a proposal. The proposal submitted by Valley Services, LLC d/b/a TRIO Community Meals conformed to all requirements of the RFP and was recommended by the evaluation committee for award. Therefore, MDHS awarded Valley Services, LLC d/b/a TRIO Community Meals the agreement. MDHS amended the agreement to reflect the increase in the U.S. Department of Labor’s Consumer Price Index. Pricing for this agreement is provided in the below chart. This agreement shall begin on October 1, 2020, and end on September 30, 2023, with an option for two (2) successive one-year renewals.
