

**MODIFICATION/AMENDMENT #1  
TO THE AGREEMENT BY AND BETWEEN  
MISSISSIPPI DEPARTMENT OF HUMAN SERVICES  
AND  
INTEGRATED PEST CONTROL MAINTENANCE**

The following Modification/Amendment #1, effective January 23, 2023, is made a part of the contract, entered into February 2, 2022, by and between the Mississippi Department of Human Services (hereinafter "Agency") and Integrated Pest Control Maintenance (hereinafter "Contractor").

Now, therefore, in consideration of the mutual agreements to modify the original contract between them, Agency and Contractor, do hereby agree that Paragraphs **4, 5, 43 and 48** of said contract shall be modified to reflect the following:

**4. Period of Performance.** The period of performance of services under this Contract shall begin on January 25, 2022, or after all parties have signed, whichever is later, and end on January 24, 2024, with the option to renew for three (3) successive one-year period(s).

**5. Consideration and Method of Payment**

a. As consideration of all services and performances under this Contract, Contractor shall be paid a fee not to exceed Eight Thousand Two Hundred Forty-Four Dollars and Zero cents (\$8,244.00) per year for the period of January 25, 2022 through January 24, 2023; Eight Thousand Two Hundred Forty-Four Dollars and Zero cents (\$8,244.00) per year for the period of January 25, 2023 through January 24, 2024. It is expressly understood and agreed that in no event will the total compensation paid hereunder exceed the specified amount of Sixteen Thousand Four Hundred Eighty-Eight Dollars and Zero Cents (\$16,488.00).

b. The Contractor will bill MDHS monthly for its services. Following the satisfactory completion of its services, as determined by MDHS, the State requires the Contractor to submit invoices electronically throughout the term of the agreement. Invoices shall be submitted to MDHS using the processes and procedures identified by the State. The appropriate documentation shall be submitted on the last working day of the month, with the final invoice to be submitted within five (5) working days after the contract ending date.

**43. Notices.** All notices required or permitted to be given under this agreement must be in writing and personally delivered or sent by certified United States mail, postage prepaid, return receipt requested, to the party to whom the notice should be given at the address set forth below. Notice shall be deemed given when actually received or when refused. The parties agree to promptly notify each other in writing of any change of address:



Any ambiguities, conflicts or questions of interpretation of this Contract shall be resolved by first, reference to this Agreement and, if still unresolved, by reference to the QR and, if still unresolved, by reference to the Quote. Omission of any term or obligation from the Agreement or QR or Quote shall not be deemed an omission from this Contract if such term or obligation is provided for elsewhere in this Contract.


